The Unimarket platform offers a range of evaluation options, so there is always one suited to the complexity or risk-level of your sourcing event.



Quick Select*

Quick Select allows buyers to evaluate responses offline in straightforward procurement situations, before recording the outcome in Unimarket. The buyer can make notes against each response and can provide feedback to the bidder through the platform. Quick Select evaluations are included with the Go to Market module.



Evaluation Matrix*

Evaluation Matrix allows the buyer to create a matrix of weighted criteria against which responses are assessed. The buyer evaluates each response against the criteria and weightings are automatically applied. Cost can be scored automatically if required. Once evaluation is complete, each response is accepted or declined, and the decision can be sent for approval or can trigger finalisation of the request or tender. The Evaluation Matrix is included with the Go to Market module. It can be used by a single buyer only.



Advanced Evaluations

Advanced Evaluations is the most powerful and flexible of the four evaluation tools. It is designed for managing complex evaluations in a highly configurable, efficient and controlled manner. It integrates closely with Unimarket Go to Market to maximise the visibility, speed and compliance of the sourcing process.

With Advanced Evaluations, users can:

- Set an unlimited number of evaluators, working individually or in teams
- Define evaluation criteria and specify mandatory requirements
- Manage criteria and mandatory requirements in a central library
- Set weightings not just for criteria but for individual questions
- Capture and manage conflicts of interest at evaluator level
- Automatically manage scoring and consensus scoring
- Maintain a full audit log for scoring, team changes and price changes

Advanced Evaluations: Consensus scores are created from individual evaluators' results and can, in turn, be overwritten and comments added.

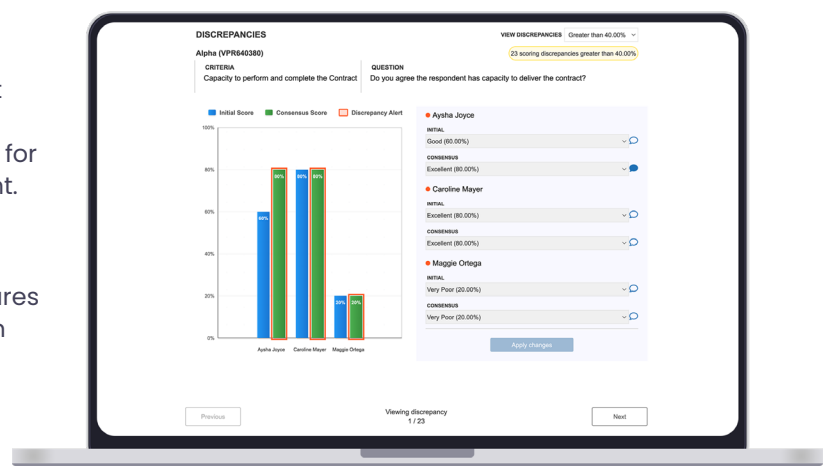
